Alameda Green matches 100% of your electricity usage with unbundled renewable energy certificates (RECs). This label describes the renewable sources of the unbundled RECs that Alameda Municipal Power will purchase to match your 2021 electricity usage.

1. These figures reflect the renewables that we have contracted to provide. Actual figures may vary according to resource availability. We will annually report to you before August 1 of next year in the form of a Historic Product Content Label the actual resource mix of the unbundled RECs you purchased.

2. New Renewables come from generation facilities that first began commercial operation within the past 15 years. This product may include generation from facilities that were approved for extended use under a strict set of criteria by Green-e® Energy and/or qualify as repowered.

For comparison, the average mix of resources that supplied Alameda Municipal Power in 2019 included: Eligible Renewable (29%), Large Hydroelectric (42%), Natural Gas (1%), and Unspecified (28%). This resource mix was prepared in accordance with CA State Law and is sent to you annually.

How will I be billed?	Your green power purchase will be listed on your AMP bill as a separate line item. This charge is in addition to your regular utility bill.						
How will my bill be calculated?	You will be charged an additional 2¢ per kWh usage per month for residential/small commercial or \$20 per 1000 kWh block for medium/large commercial and industrial. This premium is only charged on the energy (kWh) used and is in addition to all other fees and does not include charges for customer service and delivery. This purchase is in addition to charges by your electric utility and you must also pay all applicable federal, state, and local taxes and charges.						
How much will my total electricity service cost, including utility charges?	Based on the monthly average bill with a usage of 331 kWh, the following table provides you an estimate of your 2021 monthly electricity bill if you're a residential customer receiving service from Alameda Municipal Power, and the extra monthly cost for Alameda Green. Will my rates change over time?	We expect the rates for Alameda Green to remain the same over time. In the event the rate is anticipated to change, we will notify you in advance and you have the option to cancel participation in the program at any time.						
What sources will be used in my certified product?	In 2021, the resource mix will be made up of 100% wind from the Western U.S.						
What happens if I move?	If you move within Alameda Municipal Power's service territory, your enrollment in Alameda Green will move with you.						
If I want to terminate this agreement/ contract, what is the early termination fee?	You may cancel your enrollment in Alameda Green at any time with no fee by calling (510) 748-3900 or by emailing green@alamedamp.com . Changes will be effective on your next bill.						
What length of agreement/ contract is required?	This program is voluntary, you may cancel at anytime.						
What other fees might I be charged?	Delinquent bills will be assessed a late fee. If your service is disconnected for nonpayment and/or your account is past due, you may be removed from the program.
